

CARES ACT Higher Education Emergency Relief Fund
Quarterly Report 03/31/23 FINAL REPORT

1. BridgeValley Community & Technical College acknowledges that the institution signed (4/10/20) and returned (4/14/20) to the US Department of Education the Certification and Agreement form. The institution intends to use no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid grants to students. BridgeValley CTC received the second award notice on 1/26/21. The third-round award notice was received on 5/11/2021.
 2. BridgeValley CTC has received \$722,513 for Emergency Financial Aid grants to students. The award date was 4/25/20. BridgeValley CTC has received \$2,510,407 for Emergency Financial Aid grants to students. The date was 5/11/21.
 3. As of 3/31/23, \$3,955,433 has been distributed to students.
 4. The total number of eligible students is 1628 (1st award). The total number of eligible students is 1431 (2nd award). The total number of eligible students is 292 (third round). The total number of eligible students is 1455 (fourth round). The total number of eligible students is 1381 (fifth round).
 5. As of 3/31/2023, 1002 students (1st award) and 1431 students (2nd award) have received funds under the CARES Act. There are 292 students who have received funds in Summer 2021. (third round). There are 1455 students who have received funds in Fall 2021 (fourth round). There were 1381 who received funds in Spring 2022 (fifth round). In Fall 2022, funds were redistributed to 25 students due to stale-dated checks. In Spring 2023, funds were redistributed to 2 students.
 6. BridgeValley's Administration and Financial Aid Office will base funding on a formula utilizing credit hours attempted and expected family contributions to determine the grants awarded to students. Students who meet our qualifying criteria will receive an email from Bonnie Edwards, Financial Aid Manager. The email will provide additional information regarding eligibility for funds and will include a link to our certification form. Students must submit the certification form within one week of receipt to apply for the funds. BridgeValley's Administration and Financial Aid Office will base funding on a formula utilizing credit hours attempted and expected family contributions to determine the grants awarded to students for the second award. All students who qualified were awarded. In the third round, credit and non-credit students received awards. For the fourth round, all students who qualified were awarded. For the fifth round, all students who qualified were awarded.
 7. Eligible students received a generic email on April 29, 2020 and a student-specific email on April 30, 2020. Student-specific emails were also sent on May 12, May 13, and June 3, 2020. Student-specific emails were also sent on October 19, 2020. Eligible students received an email on March 10, 2021 informing them of their award. Eligible students received an email on July 28, 2021 and September 9, 2021 informing them of their award. Eligible students received an email on November 10, 2021. Eligible students received an email on April 13, 2022 and May 5, 2022. On October 12, 2022, an email was sent to eligible students offering an additional award to the first 25 students who responded. Two additional students were awarded.
