ITEM:	Recommended Change to Policy D-1 Student Rights and Responsibilities
RECOMMENDED RESOLUTION:	<i>Resolved,</i> that the BridgeValley Community and Technical College Board of Governors approves the recommended change to Policy D-1 and allow the President of BridgeValley to establish an operational policy compliant with federal and state law, and consistent with the Board of Governors policies beginning Fall 2022.

BACKGROUND:

The Code of Conduct revisions submitted to the Board of Governors during the June 24 annual meeting, were reviewed by the Board of Governors Policy Committee. During this review, it was noted that there are number of sections within the Code of Conduct that focus more on the daily operations of the institution and that it may be best suited to grant the President of BridgeValley the authority to establish an operational policy for the Code of Conduct and allow the BOG to focus on specific overarching federal, state, and Board directives.

POLICY D-1 (Draft) STUDENT RIGHTS AND RESPONSIBILITIES

Section 1. General

Scope: This policy concerns student rights and responsibilities regarding behavior, actions, and academic performance while a student at BridgeValley Community and Technical College (BridgeValley).

Application: All BridgeValley employees (faculty, staff, etc.) and students.

Effective Date: July 8, 2022

Section 2. Guidelines

The BridgeValley Board of Governors (Board) delegates to the President of BridgeValley the responsibility to establish an operational policy compliant with federal and state law, and consistent with Board directives listed below:

- Freedom of expression, assembly, and association shall be protected, and others are expected to recognize and respect these freedoms.
- Students shall be extended a right to privacy to the extent allowed by law and appropriate for BridgeValley to accomplish the mission of the college.
- Students shall not be exempt from discipline or prosecution for violation of laws or the disruption of BridgeValley activities, programs, meetings, or operations.
- Hazing of students shall not be tolerated.
- Discrimination, harassment, intimidation, or bullying on the basis of religion, race, gender, political affiliation, disability, or age shall be prohibited.
- A system of disciplinary action proceedings shall be maintained and made available to faculty, staff, and students. Disciplinary and expulsion hearings shall allow the student to present a defense to counter allegations of misconduct.
- The Board of Governors may grant an appeal to disciplinary hearing decisions as appropriate.
- The President shall provide a summary report of student expulsion hearings at the next Board meeting after the hearing has been completed, regardless of the outcome.
- Student's work shall be graded or evaluated solely upon the performance in the course as measured against an academic standard. The student shall not be evaluated prejudicially, capriciously, or arbitrarily.
