POLICY A-2

ALCOHOLIC BEVERAGES ON THE CAMPUS

Section 1. General

- 1.1. Scope — This rule establishes guidelines relating to the possession or use of alcoholic beverages on the campus.
- 1.2. Authority — W. Va. Code § 18B-1-6
- 1.3. Effective Date — July 12, 2013; Revised September 25, 2015.

Section 2. Purpose

- 2.1. It is not the purpose of this rule to promote or condone the possession or use of beer, wine or other alcoholic beverages on or in BridgeValley Community and Technical College (BridgeValley) Board of Governors' property or facilities but to regulate such possession or use within strict guidelines.

Section 3. Requirements

- 3.1. The possession or use of alcoholic beverages is prohibited on or in property or facilities of the BridgeValley Board of Governors except as hereafter provided:
 - 3.1.1. As permitted regarding the sale of nonintoxicating beer;
 - 3.1.2. In dwellings located thereon and occupied as a family residence; and
 - 3.1.3. Where the serving of wine, beer or other alcoholic beverages is approved by the President or his or her designee, on a case-by-case basis consistent with the following rules:
 - 3.1.3.a. Wine, beer or other alcoholic beverages will never be the primary reason for the gathering.
 - 3.1.3.b. The preponderance of those attending must be of legal drinking age.
 - 3.1.3.c. No person under the legal drinking age will be served.
 - 3.1.3.d. Alternative non-alcoholic beverages and food will be served.
 - 3.1.3.e. No person under the age of eighteen (18) will be allowed to serve wine, beer or other alcoholic beverages, and servers must be appropriately trained to adhere to all laws and regulations regarding the serving of wine, beer or other alcoholic beverages.
 - 3.1.3.f. No state funds will be used to purchase wine, beer or other alcoholic beverages.

Alcoholic Beverages on Campus Release of Liability Form

Per Board of Governors' Rule A-2, the President, on a case-by-case basis, may grant the approval of the serving of wine, beer or other alcoholic beverages, on limited occasions in college facilities.

The following rules are stipulated in Rule A-2 when this permission is granted:

- Wine, beer or other alcoholic beverages will never be the primary reason for the gathering.
- The preponderance of those attending must be of legal drinking age.
- No person under the legal drinking age will be served.
- Alternative non-alcoholic beverages and food will be served.
- No person under the age of eighteen (18) will be allowed to serve wine, beer or other alcoholic beverages, and servers must be appropriately trained to adhere to all laws and regulations regarding the serving of wine, beer or other alcoholic beverages.
- No state funds will be used to purchase wine, beer or other alcoholic beverages.

The signatures below affirm that permission has been granted to the requestor by the President and that the requestor agrees to abide by the stipulations above. The requestor will assume all responsibility in ensuring adherence to these guidelines, assume any and all liability incurred in the serving of alcohol, and ensure adherence to all laws of the State of West Virginia regarding alcoholic consumption.
